

The Kettering Education Foundation began in 1990 as the dream of Kettering resident, Susan Bieber, who inspired fellow founders, John Bieber, Roger Bauser, Dale Medford, and Chuck Havener, to join her in forming an organization designed to create opportunities for interested citizens, organizations, and businesses to enhance educational opportunities in the Kettering City School District.

Today we continue this mission by sponsoring a competitive grant program through which Kettering classroom teachers are able to initiate innovative and creative projects to enhance learning for their students. On behalf of donors, KEF also manages several scholarship funds that award several thousand dollars annually to graduating Kettering Fairmont High School seniors.

What We've Been Up To

For the 2013-14 school year, 20 teachers received classroom grants. For 2014-15, the number was 22.
