Who We Are

The Kettering Education Foundation Advisory Board is an all-volunteer group, comprised of community leaders, former educators, and business associates. Additional input and advice is provided by a liaison with The Dayton Foundation (TDF), ex-officio members, and emeritus trustees. The Kettering Education Foundation (KEF) is a component fund of The Dayton Foundation.

We sponsor a competitive grant program through which Kettering classroom teachers are able to initiate creative projects to enhance learning for their students. On behalf of donors, KEF also manages scholarship funds that award several thousand dollars annually to graduating Kettering Fairmont High School seniors.

What We've Been Up To

Nineteen teachers have been chosen to receive a classroom grant of up to \$1,000 each. These projects, described on the next page, will be implemented during the 2019-2020 school year.

In May, KEF presented scholarships to 12 outstanding Fairmont graduating seniors and 1 Oakwood senior. Information about the scholarships and this year's recipients appears on Page 3 of this report.

Since its inception, the Kettering Education Foundation has raised more than \$300,000 and has awarded more than 300 grants. Funds raised have helped the Kettering Education Foundation achieve its vision: to provide support for the Kettering School District's efforts to be an innovative leader in K-12 education throughout the Miami Valley.

2019-2020 GRANTS

The Kettering Education Foundation awarded teacher grants to 19 Kettering teachers for the 2019-2020 school year: 15 new grants and 4 renewals. KEF is pleased to sponsor these teachers for their innovative classroom ideas.

At Indian Riffle Pandy Pugh's students in grades 2-5 will have access to POST 2, an interactive system to adapt story activities for a classroom reading center to help improve students' reading comprehension.

At Fairmont High School, Meghan Dillon will promote LITERACY IN THE ART ROOM

by incorporating current, relevant texts to her visual arts curriculum, having students read and respond through visual, oral, and written activities. This will help the students practice their reading skills in a specific content area for testing, college preparation, and career readiness.

Kelly Zecchini at Kettering Middle School will help plan a **RE-DO DAY** where students learn to Respect their peers, Engage the people around them, Defend anyone being bullied, and Overcome stereotypes. This is a day-long program led by the Violence Free Coalition, helping students increase respect and empathy for others and reduce bullying. This grant entails additional funds from other sources.

Special education students in grades K-8 at Ascension will continue to use an IXL **program** with teacher Amanda Lymburner to reinforce math and language arts skills. This is an online program aligned to the Common Core standards by grade level, designed to help students meet their IEP goals and close skills gaps.

A MISSION TO MARS ANCHOR

ACTIVITIES will help Deborah Everett's 5th graders at Indian Riffle Elementary School on their Ohio Air Test. Students will make connections between standards for life science, physical science, and Earth and space science by investigating different aspects of a mission to Mars through the school year.

Carly Bach will implement **STEMming INTEREST IN 1ST GRADE**

at Oakview Elementary, putting together STEM bins with task cards for students to solve. This project will integrate various standards in an interactive way, developing critical and creative thinking and problem-solving skills.

CATAPULT YOUR WAY TO LEARNING!

is Becky Brandenburg's project for 5th graders at John F. Kennedy Elementary. She plans to do a forces and motion unit, simplifying concepts for the physical science standards to help create lasting memories by increased knowledge of Newton's Laws.

At Orchard Park Elementary Cary Forlines will be creating a **SENSORY PATH** to help accommodate students with sensory needs to decrease classroom distractions and support all academic and curricular areas.

Amy Scott at Oakview Elementary will also be creating a SENSORY PATH to provide structured and visually appealing space for needed physical activity to improve classroom behavior and to maximize learning.

Heather McManus will use 3rd **GRADE INDIVIDUAL STUDENT RESOURCE**

KITS at Indian Riffle Elementary to make individualized bins to give students access to resources to build their fluency and independence in math and language arts by using higher level thinking and abstract skills.

At Fairmont High School Kelsey Mann will continue her **DIVERSITY IN LITERATURE** program by giving students more opportunities to claim ownership of their learning and to gain excitement for reading and empathy for others.

Van Buren Middle School students in Elizabeth Hageman's classes will be able to PICTURE THIS! A PICTURE (BOOK) IS WORTH A THOUSAND WORDS with these award-winning social studies picture books from ancient Greece to the first global explorers. The students will learn content as the books make ancient history come alive, piquing curiosity and supporting the social studies content standards.

Richard Wright will organize **a DAYTON PHILHARMONIC KIDS**

CONCERT at Fairmont High School for his 8th-12th grade instrumentalists and will work with staff and orchestra to produce educational materials for students to use before and after the performance. This grant entails additional funds from other sources.

MATH IS NOT A SPECTATOR SPORT

in Nancy Galusha's class at Orchard Park Elementary. Students will develop perseverance and problemsolving strategies through math games as they learn their content standards.

At Van Buren Middle School Ben McCombs will continue his project: **ROBOTS**—**HELP THEM HELP** YOU! This year his students will have a chance to work their robots toward a specific task addressing state standards.

Molly Hughes will implement **KINDERGARTEN LANGUAGE ARTS CENTERS** at John F. Kennedy

Elementary School. Students in all-day kindergarten will have a hands-on, languagerich environment with these literature centers based on the English Language Arts standards.

Jessica Hanchak at Beavertown Elementary will be **FINDING** TIME FOR FUN LEARNING as she continues her lunch bunch meetings with games promoting 4th grade reading and physical science standards, helping her build relationships with students and families through games the students can also check out to play at home.

Pandora Pugh will create theme boxes for a manipulative approach to the curriculum for a self-contained autism classroom in her HANDS-ON IN POST at Indian Riffle Elementary School.

Elizabeth Hann's students at Fairmont High School will have a hands-on experience in the fusing of glass to help students in her materials science class understand concepts involved with glass and temperature as students COME TOGETHER: THE ART **OF GLASS FUSION.**

Oakview Elementary students in Sherry Hawley's class will find **BOUNTIFUL BOOKS** as Ms. Hawley builds novel sets for a new level of students, making connections and increasing comprehension with both reading and writing skills.




Cheryl Abraham Memorial Scholarship


