2016-2017 GRANTS

The Kettering Education Foundation (KEF) awarded teacher grants to 27 Kettering educators for the 2016-2017 school year: 20 new grants and 7 renewals. KEF is pleased to sponsor these teachers for their innovative classroom ideas.

Art teacher Kristin Mitchell will be working with third grade students at Indian Riffle Elementary School (IR) to create large mural paintings of famous artworks. These paintings will be used as a backdrop for THE LIVING MURALS performance, a cross-curricular collaboration with the music and physical education teachers.

Lindsay Gustafson will continue her SILKWORM FARMING AND NEEDLE

FELTING with sixth grade art students at Kettering Middle School (KMS), helping students make connections between art and science.

At Van Buren Middle School (VB), Carol Harris and her sixth grade language arts students will explore the concept of change in our world and how it affects them by studying fiction and nonfiction from the Civil Rights Movement, culminating in a multimedia presentation: EYES WIDE **OPEN, A STUDY OF CHANGE** USING 21ST CENTURY SKILLS.

Christy Kremer's fourth graders at JE Prass Elementary School (Prass) will continue to learn real world math skills and financial literacy in THE MATH SPOT.

At Oakview Elementary School (Oakview) second grade students in Jodee Ball's class will use the LADIBUG **DOCUMENT CAMERA** to help students focus on logical and mathematical thinking, including spatial construction and problem-solving.

Beavertown Elementary School (Beavertown) teacher Rodney Carver's students will be engaged with their new INNOVATION STATION, a location that promotes collaboration, communication, and problem-solving as students create products, tackle problems and devise inquiry strategies.

At Fairmont High School (FHS), the AP/IB juniors will use NONFICTION READING WITH A LITERATURE CONNECTION to develop skills across

content areas. Three English teachers—Emily Bruzzese, Ryan Lamb and Kelsey Mannwill help their students learn How to Read Literature Like a Professor.

SNAP CIRCUITS, an electronics discovery kit, will give Amy Lokai's fourth grade students at Prass hands-on experience with the physical science standards while designing and building models of working electrical circuits.

Southdale Elementary School music teacher Adam Depew will expand his K-5 music program with MARIMBA **MOJO!** The addition of marimbas will provide the opportunity for students to play a multitude of styles included in the state and national standards.

VB's Jeffrey Bohaboy will help his career/industrial arts students go from a thought to a sketch to a 3D model in the virtual world to an actual object with his 3D PRINTING project.

John F. Kennedy Elementary School's Ann Muth will be **TEACHING SOCIAL STUDIES** THROUGH CHILDREN'S LITERATURE, pairing fiction

and nonfiction texts to teach the social studies standards.

MaryEllen Sage will continue with HANDS-ON MATH IN THE **MIDDLE SCHOOL**, introducing and reviewing math concepts with her sixth graders at KMS.

PRESCHOOL BOOK BUDDIES

will help inspire a love of books for Bridget Shampton's second graders at IR while increasing their knowledge and understanding of oral vocabulary, developing reading fluency and improving their social skills.

CODING WITH DASH AND DOT

will be a new program for Kimberly Ulrich's third grade students at Orchard Park **Elementary School. Students** will program robots to play music, connect blocks, and learn code and computer science skills.

Patricia Taylor's English students at FHS will continue to make **REAL WORLD CONNECTIONS THROUGH RIGOROUS FREE READING**

CHOICES. This project will provide challenging reading materials beyond the curriculum, adding rigor to help students meet state standards and to increase their overall reading levels, benefiting them in all subjects.

Using interactive child/parent texts, Prass first graders in Carrie Henry's class will improve reading skills with WE BOTH READ, working on fluency, comprehension and vocabulary.

FHS teacher Laura Heitz will start a TRANSITION ART AND **MODEL CLUB** for adult students at Barnes to help them develop functional life skills including employability, transportation, money management and recreation.

Trisha Himes, KMS social studies teacher, will help her eighth grade students explore **COLONIAL DAYS**, focusing on evaluating primary sources to gain a better understanding of the American colonial period.

At VB, Jill Spurlin will continue to use the STEM PROJECTS IN THE SCIENCE 8 CURRICULUM to engage students by solving real world problems like

earthquake-proof buildings, rocks as building materials, water and soil testing, and dye capacity in fabrics.

With LEARNING THROUGH A

LENS, Kim Seitter will help her Oakview students develop their language arts skills by using a document camera to enable students to identify text features: headings, subheadings, glossary, index, italicized words and table of contents.

Students in Beth Frederick's fifth grade class at IR will blend language arts and science with graphic novels and nonfiction texts, using resources to produce summaries, to compare and contrast, and to write essays with this **SUPER SCIENCE READING AND WRITING** project.

At FHS Stephen McDonald's social studies students will learn REAL WORLD STOCK MARKET INVESTING, exploring the basics of how to invest in the stock market and how to evaluate various companies while sparking an interest in personal finance and planning for their future.

3D PRINTING IN THE MIDDLE

SCHOOL CLASSROOM will enable the career/industrial arts students of KMS teacher Allison Mittelkamp to design and model a light switch cover, using measurement, problem-solving and critical thinking skills.

CREATING A TINKERING SPACE TO EXPLORE THE **ENGINEERING DESIGN PROCESS AND STEM CAREERS**

sums up Joseph Duncan's project for his seventh graders at VB. Students will use the space to design and simulate a project through scientific inquiry, utilizing the engineering design process.

Sharon Tolle's eighth grade language arts students at KMS will continue KEEPING IT REAL as they explore biographies and memoirs to improve their reading strategies.


